- (b) Benedette was asked by "Mr. Onyango" to find a buyer for his restaurant in exchange for a payment of 15% of the sales price if she found a buyer. Benedette did not have a real estate license nor did she claim to have one. She obtained a buyer and was paid one-half of the commission. Onyango refused to pay any more commission saying that he did not have to since Benedette did not have a realtor's license as required by state law. Is he correct? He also said that Benedette had to return the part of the commission that he had already paid to her. Expound on the legality of Mr. Onyango's actions? (8 marks)
- (c) Hassan Abdi, a 15-year old boy who looks older, just signed a contract joining a health club which has "dues" of Kshs. 5,000 a month. Is this contract valid?
