Question One

Question Three

What is disaster preparedness? Discuss the role of a disaster preparedness and management student before and after a fierce fire has struck a slum area in a town next to where he/she stay. (5 Marks)

Question Four

What is the role of an institution such as a school/university in disaster management? Give the significance of community counseling sessions after a disaster. (5 Marks)

Question Five

List at least a minimum of five events, five hazards and five natural hazards. Elaborate when epidemiological events actually become disasters to society. (5 Marks)

Ouestion Six

'One of the most important steps you can take to prepare for emergencies is to develop a household disaster plan'. By giving five examples, discuss the pros and cons of taking such a step to mitigate on effects of an impending disaster. (5 Marks)
